Eligibility:

The 2018 AZ Art Alliance Holland Gallery Summer Exhibit is open to ALL Art Alliance Member Leagues that are in good standing at the time of the drawing to be held October 25, 2017 and for the year 2018. Each Member League will be asked to RSVP by e-mail their wish to participate in the Summer 2018 Exhibit. The deadline for your League to reply is October 10, 2017.

At our October 25, 2017 Presidents' and Rep Meeting, we will hold the drawing to determine which Leagues will show for each month June/July 2018). It is our hope that every League will have a one-month Show, even assuming a full response. We plan to make this a yearly Event.

Each Member League (with primarily 20 artists) will be allowed approximately 17ft. x 5 ft. of wall space. Each League will determine how to fill that space with 20 artwork, but must allow 8"-10" of spacing between works (for tags and to prevent overcrowding). Each primarily 20 League will, if desired be allocated ONE pedestal (approx. 18' by 18" on top) to accommodate one 30 work.

Member Leagues that specialize in ONLY or PRIMARILY 30 artwork will be given preference for 30 space. Two locking glass display cases (66"H x 18"W x 13"0) will be available to those 30 Leagues. A second random drawing will be held at the October 25 Rep Meeting for the 30 Leagues. The 30 Leagues will not be eligible for wall space, nor will 20 Leagues be eligible for the display cases. (Should some groups choose not to participate, we may adjust space type & allocation for those groups who *are* participating.)

Each Member League will determine what their requirements will be for participation in that League's Exhibit with these following provisions: 1) All artwork must be for sale and priced at a minimum of \$175, including jewelry pieces; 2) All art must be the artist's original work; 3) Art must look professionally framed with wire adequate to support the work (**no saw-tooth hangers**); 4) this venue does not allow nudes.

There will be no jurying by the Art Alliance and no use of Entrythingy for this Show.

Each Member League will be required to hang and to take down its own Exhibit under the supervision of Art Alliance personnel.

Artists/Member Leagues MUST adhere to delivery and pick-up times. Work not removed will result in a \$20 handling fee.

IMPORTANT!

Each League will be responsible for its own show tags (must be white, business card size) that should include Title Artist's Name, League Name and/or Logo, Medium, and Price.

Each League will be asked to provide a sign to identify their group's artwork with the League's Name printed on it. For consistency, each sign must be printed on black PVC, 8 inches high, with 4-inch Helvetica Condensed font. The length of the sign and cost will depend on the length of your League Name. (A 4-foot long sign would cost about \$60, an 8-foot sign about \$91. We suggest you use Fast Sign. These signs are yours to keep.

THERE ARE NO LEAGUE ENTRY FEES FOR THIS SHOW. THIS EXHIBIT IS GRATIS AND A GREAT OPPORTUNITY FOR OUR MEMBER LEAGUES TO SHOW OFF THEIR TALENT WITH MINIMAL EXPENSE.

A contribution of 20% will be retained by Foothills Community Foundation on each sold item. No artist contribution will be taken by the Art Alliance.

For the convenience of Gallery personnel, all work must be clearly labeled on the back with the Artist's Name, Title of Work, & Medium. The Art Alliance will pay the venue fee to Holland Gallery/Foothills Community Foundation. There will be no entry fee to Member Leagues or to Artists. However, other fees associated with the Member League's Exhibit (signs, tags, etc.) will be the responsibility of the Member League.

Artists retain copyright to the artwork, however AZ Art Alliance reserves the right to photograph & publish images of artwork for this and future exhibitions, and for use in the AZ Art Alliance newsletter.

This Exhibit will also highlight the Art Alliance Outreach Programs. An area of the Holland Gallery will be designated to display information about our Outreach and to display/offer for sale art from Outreach participants and instructors.

Terms of Entry:

I have read, understand, and am in agreement with the entire contents of this Prospectus and though every effort will be made to protect submitted artworks, I understand that the AZ Art Alliance, its artists & volunteers, and the Holland Gallery, its volunteers & staff will assume no responsibility or liability for loss or damage.
